**The Undersigned takes note that:**

- the activity will take place within the waters of the Protected Area as follows: land-based briefing giving introduction to the environment, flora and fauna of the Protected Area, rules on behaviour expected in the water, and the route planned; transfer to the Bagno Ducale, kitting up and subsequent diving at sea;
- taking part in the activity requires that he/she holds a **valid and recognised diving certificate**;
- the Minor has suitable diving equipment; **otherwise he/she will use MPA diving equipment**;
- in order to be authorised to dive, each group, made up of a maximum of 8 people, must be accompanied by two qualified diving instructors (one per 4 people), who will be responsible for safety during the entire activity;
- each group will also be assigned an accompanying MPA guide, who will carry out the introductory briefing and will monitor the activity in the water to ensure the divers pay due respect to the protected environment;
- all participants must observe the regulations for behaviour in force in the Miramare MPA (Ministry Regulations, which can be consulted online through: <http://www.riservamarinamiramare.it/area-marina-protetta/cos-e> or directly on request at the Visitor Centre Reception);
- participants must obey the instructions and orders of the Miramare MPA accompanying guide regarding any behaviour that might cause damage to the protected species and habitats: failure to do so might cause the visit of the whole group to be halted;
- in consultation with the MPA guide, the instructors may halt an activity at any time should the meteorological conditions be deemed unsafe for pursuing sea-based activities, or should the behaviour of an individual or of the group be inappropriate for individual or collective safety.
