## Application to participate in sea-watching activities at the Miramare Marine Protected Area

**hereby submits a request** for the above minor to participate in guided sea-watching activities at the

#### **The Undersigned takes note that:**

- the activities include an outing at sea, which will be led by an approved WWF Oasi guide, who will lead groups in the sea, these groups consisting of no more than eight participants per guide;
- taking part in sea-watching requires ability to swim autonomously and without buoyancy aids, in waters that can reach 3 meters in depth;
- correct use of a snorkel will be necessary for breathing during fin-swimming on the surface;
- those with limited mobility will not necessarily be able to fully access all structures and areas where the activities take place (presence of steps into the sea, slippery zone at the tidal edge);
- all participants must adhere to the Miramare MPA regulations in force (Ministry Regulations, which can be found online at: <http://www.riservamarinamiramare.it/area-marina-protetta/cos-e>);
- throughout the visit, participants must respect the instructions and orders of the WWF Oasi accompanying guide or staff in general, both within the WWF Oasi areas and external to them;
- the WWF Oasi – Miramare MPA guide or staff may halt an activity at any time should the meteorological conditions be deemed unsafe for pursuing sea-based activities, or should the behaviour of the minor or of the group be inappropriate for individual or collective safety, or should there be failure to respect the rules set out under Environment Ministry Regulations;
- the WWF Oasi guide or staff may suspend an individual participant from pursuing an activity – ensuring that person is supervised – should their psycho-physical conditions be considered unsuitable or should they disobey the guide's instructions or the Marine Area regulations;
- the equipment used is that provided by the organisation, free of charge, disinfected each time of use;
- all participation fees must be paid in full before the activities begin.
